A reminder about the Government incentives around **apprenticeships**. If you recruit an apprentice between August 2020 to January 2021 you could be eligible for a cash incentive of up to £4,000.

- Start a new apprentice aged 16-24 and receive £2,000
- Recruit a new apprentice aged 25+.and receive £1,500
- Offer a short work placement of 100 hours and receive £1,000 per person
- □ This is in addition to the existing £1,000 incentive already provided for new

apprentices aged 16-18

And finally – the consultation around the proposals for **road improvements to Simister Island** (interchange of M60, M62 and M66) closes on 17th August – so make sure you have your say.

Highways England have announced proposals to improve the Simister Island Interchange between the M60, M62 and M66. The interchange is one of the busiest motorway junctions in the north-west used by around 90,000 vehicles each day. The junction was not designed for this level of traffic and as a result suffers from congestion and poor journey time reliability.

Two options have been developed for the proposed project which will provide additional capacity through the junction. These options would provide quicker, more reliable and safer journeys into and around Greater Manchester, with fewer unexpected delays.

Highways England are now holding a public consultation on their plans and would like to hear your views, concerns or ideas.
